RE: Application for Local Bridge Program – for Bridge Replacement and Preventative Maintenance

The State of Michigan, Department of Transportation (MDOT) is currently soliciting applications to the Local Bridge Program. Selected projects will be funded during the 2025 fiscal year. This program awards funds to local government agencies for bridge structures that the local agencies consider in critical need of replacement, rehabilitation, or preventative maintenance.

The Department of Public Works (DPW) has identified the following structures as requiring preventive maintenance activities, and will provide the necessary funds from the street fund for the design and construction engineering in addition to the percentage funding match listed below for the construction phase:
