The Michigan Department of Health and Human Services (MDHHS) has awarded an increase in appropriation to the City of Detroit Health Department for FY 2023 Southeast Michigan Infant Vitality Grant, in the amount of \$25,000.00. This funding will increase appropriation 21215, previously approved in the amount of \$25,000.00, by council on October 11, 2022, to a total of \$50,000.00.
