RE: Request to Accept and Appropriate the FY 2022 City Inclusive Entrepreneurship Grant Program

Honorable City Council:

The National League of Cities Institute (NLCI) City Inclusive Entrepreneurship (CIE) Program has awarded the City of Detroit Housing and Revitalization Department-Office of Immigrant Affairs Entrepreneurship Program Grant for a total of \$15,000.00 with no matching requirement. The grant will support the implementation of its Informal Entrepreneurship Commitment with no match requirement.

Congratulations! The National League of Cities Institute (NLCI) City Inclusive Entrepreneurship (CIE) Program is pleased to provide a grant of \$15.000 to the City of Detroit, MI to support the implementation of its Informal Entrepreneurship Commitment. The City of Detroit will work with the International Institute of Metro Detroit as the approved partner to achieve the following outputs and outcomes:

- Initiating Activity: As of November 2022, you have identified the sector you want to explore and 1-3 nonprofit leaders working in that sector with whom you may consider as community partners.
- Mid-year Output: By April 2023, you will 1) select a nonprofit to apply as a Rising Tide Capital affiliate and complete program training and capacity building to execute a Community Business Academy for informal entrepreneurs, or 2) create a customized plan for conducting an outreach and registration program for informal entrepreneurs through their own efforts or in partnership with a local nonprofit.
- End-of-Year Outcome: By August 2023, you will register at least 5 new businesses as a result of direct outreach and technical assistance, as measured by city permitting records.

By accepting this grant, your city and/or organization agree to the following:

- Grantee, in partnership with assigned program expert and key ecosystem partners, will implement the commitment above and achieve commitment outcome by the end of the grant performance period, or advance its selected commitment through another method, pre-approved by NLCI.
- Grantee is required to complete an interim progress report, including a self-report on budget allocation status, to NLCI midway through the grant performance period (May 2023).
- Grantee is required to complete a final grant report, including a self-report on budget allocation status and a summary of lessons learned, to NLCI at the conclusion of the grant performance period (August 31, 2023).
- Keep NLCI staff apprised of commitment implementation progress, including unexpected setbacks or staffing changes, throughout the grant performance period.
- If necessary, be available to conduct a formal post-grant interview.
- Ensure that the programmatic lead for the city or at least one staff person from the city attends every quarterly group conference call.

- Spend all funds or return to NLCI any remaining unused funds by the end of the grant performance period.
- If funds remain at the conclusion of the performance period, Grantee will contact NLCI staff to discuss the possibility of a "No Cost Extension" (NCE), returning grant funds, and/or other options.

Upon receipt of this MOU and any other required documents, NLCI will disburse all funds in a single payment via direct deposit. Funds can be expected to arrive within 7-10 business days after an award is made. Please confirm receipt of funds.
