Brief Statement of Priorities/Purpose for the Application <i>Sample: To support expansion of promising youth development programs in MNO neighborhood.</i>	During the environmental investigative sampling performed by GEI for Preserve on Ash I (3303 14TH ST et al), mercury and arsenic contamination was found in nearly every onsite soil boring sample. Other contaminants, including volatile organic compounds and polynuclear aromatic hydrocarbons have also been found in scattered samples at concentrations above direct contact and VIAP. Grant funds will be used for assessment, due care and remediation for contaminated parcels within the POA Phase I and Phase II projects.
