The National Park Service has awarded the City of Detroit Historic Designation Advisory Board with the FY 2022 Historic Preservation Fund-History of Equal Rights (HER) Grant for a total of \$75,000.00. The Federal share is \$75,000.00 of the approved amount, and there is a required in-kind match of \$10,000.00. The total project cost is \$85,000.00.

The objective of the grant is to perform a structural assessment and complete a Historic Structure Report (HSR) for the Detroit Association of Colored Women's Clubs building, located at 5461 Brush Street, Detroit, MI 48202. The funding allotted to the department will be utilized to provide contractual services to complete the Report. This is a reimbursement grant.

If approval is granted to accept and appropriate this funding, the appropriation number is 21260, with the match amount coming from appropriation number 28520.
