We have reviewed the above-captioned lawsuit, the facts, and particulars of which are set forth in a confidential memorandum that is being separately hand-delivered to each member of Your Honorable Body. From this review, it is our considered opinion that a settlement in the amount of **SEVENTY-FOUR THOUSAND TWO HUNDRED FIFTY DOLLARS AND NO/CENTS (\$74,250.00)** is in the best interest of the City of Detroit.

We, therefore, request authorization to settle this matter in the amount of Seventy-Four Thousand **TWO HUNDRED FIFTY DOLLARS AND NO/CENTS (\$74,250.00)** and that Your Honorable Body direct the Finance Director to issue drafts in the amount of **TWO THOUSAND DOLLARS AND NO/CENTS (\$2,000.00)** payable to **SEAN HAYES** and **HIS** attorneys, **APPLEBAUM & STONE, PLC**; **FIFTY-NINE THOUSAND FIVE HUNDRED DOLLARS AND NO/CENTS (\$59,500.00)** payable to **KRISTOPHER MADISON** and **HIS** attorneys, **APPLEBAUM & STONE, PLC**; and **TWELVE THOUSAND SEVEN HUNDRED FIFTY AND NO/CENTS (\$12,750.00)** payable to **CALVIN THORNTON** and **HIS** attorneys, **APPLEBAUM & STONE, PLC**; to be delivered upon receipt of properly executed Releases and Stipulation and Order of Dismissal entered in Lawsuit No. 20-008694-NF, approved by the Law Department.
