On July 12, 2023, a case evaluation panel evaluated the above-captioned lawsuit and awarded **FIFTEEN THOUSAND DOLLARS AND <sup>NO</sup>/CENTS (\$15,000)** in favor of the plaintiff. The parties have until August 9, 2023, to either accept or reject the case evaluation.

Based upon our review of the facts and particulars of this lawsuit, which are set forth in a confidential memorandum that is being separately hand-delivered to each member of Your Honorable Body, it is our considered opinion that a settlement in the amount of **FIFTEEN THOUSAND DOLLARS AND <sup>NO</sup>/CENTS (\$15,000.00)** is in the best interest of the City of Detroit.

We, therefore, request Your Honorable Body to authorize settlement of the above referenced lawsuit and to direct the Finance Director to issue a draft in that amount of **FIFTEEN THOUSAND DOLLARS AND <sup>NO</sup>/CENTS (\$15,000.00)** payable to **US HEALTH PHARMACEUTICALS LLC** and **their** attorneys, **HIRSCH, GAUGIER & KHAN**, to be delivered upon receipt of properly executed Releases, Stipulation and Order of Dismissal entered in Lawsuit No.22-010280-NF and, where deemed necessary by the Law Department a properly executed Medicare/CMS Final Demand Letter.
