## Honorable City Council:

The City of Detroit, Planning and Development Department ("P&DD") has received an offer from M&M Pet Detroit, LLC, a Michigan Limited Liability Company (the "Purchaser"), to purchase certain City-owned real property at 15621 E. Warren, 15617 E. Warren, 15613 E. Warren, 15609 E. Warren, and 15601 E. Warren, Detroit, Michigan 48224 (the "Properties") for the purchase price of Twenty-Five Thousand and 00/100 Dollars (\$25,000.00).

The Properties consists of five vacant lots Purchaser would like to acquire to serve as customer parking for its active pet supply business located adjacent to the Properties at 15625 E. Warren Ave, Detroit, MI 48224. The Properties are within a B4 zoning district (General Business District), and Purchaser's proposed use of the Properties is a by-right use and is consistent with the allowable uses for which the Properties are zoned.

We request that your Honorable Body adopt the attached resolution to authorize the Director of P&DD, or his or her authorized designee, to execute a quit claim deed and such other documents as may be necessary or convenient to effect a transfer of the Property by the City to M&M Pet Detroit, LLC, a Michigan Limited Liability Company.

NOW, THEREFORE, BE IT RESOLVED, that Detroit City Council hereby approves of the sale of certain real property at 15621 E. Warren, 15617 E. Warren, 15613 E. Warren, 15609 E. Warren, and 15601 E. Warren, Detroit, Michigan 48224 (the "Properties"), as more particularly described in the attached Exhibit A incorporated herein, to M&M Pet Detroit LLC, a Michigan Limited Liability Company ("Purchaser"), for the purchase price of Twenty-Five Thousand and 00/100 Dollars (\$25,000.00); and be it further

**RESOLVED**, that the Director of the Planning and Development Department, or his authorized designee, is authorized to execute a quit claim deed and other such documents necessary or convenient to effect transfer of the Property to Purchaser consistent with this resolution; and be it further

**RESOLVED**, that the following Property Sales Services Fees be paid from the sale proceeds pursuant to the City's Property Management Agreement with the Detroit Building Authority ("DBA"): 1) Two Thousand Five Hundred and 00/100 Dollars (\$2,500.00) shall be paid to the DBA from the sale proceeds, 2) One Thousand Two Hundred Fifty and 00/100 Dollars (\$1,250.00) shall be paid to the DBA's real estate brokerage firm from the sale proceeds and 3) customary closing costs up to Two Hundred and 00/100 Dollars (\$200.00) as well as any taxes and assessments which have become a lien on the Property; and be it further

**RESOLVED**, that the P&DD Director, or his authorized designee, is authorized to execute any required instruments to make and incorporate technical amendments or changes to the quit claim deed (including but not limited to corrections to or confirmations of legal descriptions, or timing of tender of possession of particular parcels) in the event that changes are required to correct minor inaccuracies or are required due to unforeseen circumstances or technical matters that may arise prior to the conveyance of the Properties, provided that the changes do not materially alter the substance or terms of the transfer and sale; and be it finally

**RESOLVED**, that the quit claim deed will be considered confirmed when executed by the P&DD Director, or his authorized designee, and approved by the Corporation Counsel as to form.
