RESOLUTION IN SUPPORT OF AN INCREASE IN PUBLIC EDUCATION REGARDING CITY WASTE SERVICES, RECYCLING, AND LITTERING.

- WHEREAS, Since Detroit implemented a city-wide recycling program, residents have steadily chosen to opt into the program and over 40% of households currently participate in the recycling program; and
- WHEREAS, Although participation in the recycling program is growing, there is a need to educate the general public regarding which types of materials can be recycled and the benefits of recycling in order to increase the number of households who opt in to the program and to reduce the amount of contaminated materials placed in recycling bins; and
- WHEREAS, There is also a need to educate the public regarding the proper disposal of bulk waste, the various ways that members of the public can inadvertently receive blight tickets, and the benefits of reducing littering city-wide; and
- WHEREAS, Although the city may exercise police power to encourage compliance with the Detroit City Code regarding proper disposal of waste, it is essential to ensure that the public is aware of the benefits of compliance to encourage voluntary participation; and
- WHEREAS, Increasing voluntary compliance with the city's waste disposal and recycling programs is a matter of public health and safety. Additionally, reducing the amount of littering and illegal dumping will aesthetically improve Detroit neighborhoods, which will provide psychological benefits to residents and positively impact property values; NOW, THEREFORE BE IT
