RESOLUTION

BY DETROIT CITY COUNCIL MEMBER _____ :

WHEREAS, City Council shall apportion the districts of the City prior to the next general municipal election that occurs no earlier than four months following the date of the official release of the census figures of each United States Decennial Census, in accordance with MCL 117.27a; and

WHEREAS, the 2025 general municipal election is the first general municipal election that occurs no earlier than four months following the date of the official release of the census figures of the 2020 Decennial Census; and

WHEREAS, MCL 117.27a requires that the reapportionment plan shall provide for districts which are as equal in population as practicable and contiguous and compact; and

WHEREAS, the maximum population deviation between the largest and smallest district must be less than 10 percent; and

WHEREAS, City Council must reapportion the City's districts because the 2020 United States Decennial Census determined that the populations of the districts are outside of the maximum population deviation allowable; and

WHEREAS, in order to enact the reapportionment plan, City Council must approve the plan and file the reapportionment plan with the City Clerk, in accordance with MCL 117.27a; and

WHEREAS, based upon the census figures of the 2020 Decennial Census and the requirement to reapportion districts in a manner that is as equal in population as practicable and contiguous and compact, City Council has reviewed the attached reapportionment plan; and **NOW, THEREFORE, BE IT**

RESOLVED, that the Detroit City Council approves the attached reapportionment plan; and

BE IT FURTHER RESOLVED, notwithstanding the new district boundaries approved in the reapportionment plan, any elected or appointed City official who was elected or appointed prior to approval of this reapportionment plan, is required to maintain residency in the City district to which they were elected or appointed, and has not moved residences outside of the original district, shall continue to serve as the representative for that district until their term ends and a successor is sworn into office, or their office otherwise become vacant in accordance with applicable law; and

BE IT FURTHER RESOLVED, that the approved reapportionment plan is filed with the City Clerk; and **BE IT FINALLY**

RESOLVED, that such plan is approved, and shall have legal effect 30 days after the City Clerk publishes the plan, and shall become effective for the 2025 general municipal election, in accordance with Federal, State, and City law.
