**RE: Request to authorize acceptance and appropriation of Cash and In-kind Donations to support #FunInTheD activities associated with the 2024 NFL Draft**

The General Services Department, in partnership with the Office of Development and Grants, is requesting authorization to accept cash and in-kind donations to support #FunInTheD activities for residents before and during the 2024 NFL Draft that will be hosted by the City.

The objective of the donations is to support sports related youth activities and events that will be held at various City of Detroit recreation centers. Donations may include cash and in-kind goods and services. In-kind donations may include, but are not limited to, sporting goods, food and refreshments, and event supplies.

This requested resolution also does not apply to grants. All individual grants will continue to be submitted to Council separately for authorization to apply, accept and appropriate. If approval is granted to accept donations for the 2024 NFL Draft, the General Services Department will receive such donations and will be authorized to use them, provided that they report all donations received to the Office of Development and Grants.

If this request is approved, the Office of Development and Grants will submit a report of all cash and in-kind donations received, 90 days after the conclusion of the 2024 NFL Draft.

If approval is granted to accept and appropriate receipt of the cash donations, the appropriation number is 21384.
