Declaration of No Rights

Only Black Detroit does not have a right to expect aggressive action by the city's officers in seeking to advance, conserve, maintain and protect the integrity of the human, physical and natural resources of this city from encroachment and/or dismantlement for Black Detroit.

Only Black Detroit does not have a right to expect city government to provide for its residents, decent housing; excellence in education; job opportunities; reliable convenient and comfortable transportation; recreational facilities; organized programs of recreational activities; cultural enrichment, including libraries and art and historical museums; clean air and waterways, safe drinking water and a sanitary, environmentally sound city for Black Detroit.

What It Took To Drive Black People Out Of Detroit

1. Black generational wealth striped from our community by destroying Black home ownership.
2. The Detroit City Council approved \$60,000,000.00 tax waiver for billionaire Dan Gilbert but refuse to refund or give credit for \$600,000,000.00 property taxes over charged.
3. **Mike Duggan's Administration participated in stealing \$600,000,000.00+ in over assessed property taxes causing property owners to lose homes for taxes never owed and refused to give a credit or refund, then came back and ask for \$250,000,000.00 (Proposal N) using our homes as collateral.**
4. After the takeover of our public school system, to make way for profit driven charter schools and the dismantling of Detroit Public Schools, Mike Duggan got the first \$80,000,000.00+ of our \$1,500,000,000.00 (One & one-half BILLION dollars) that was intended to upgrade Detroit Public School buildings which are now abandoned eyesores or given away for pennies on the dollar.
5. Corporate slum landlords feeding off renters, who lost their homes to \$600,000,000.00 property tax theft.
6. A \$350,000.00 no-bid booty call for Mayor Mike Duggan's paramour under the cover of a non-profit studying Black Infants and new mothers.

7. Corrupt, inept, coward, self-serving, subservient and weak Detroit City Council that behaves as if they must have Mike Duggan's approval to vote "No" on his issues harmful to Black Detroiters. City Council is a separate arm of city government whose main responsibility is approval/reject and budget in the interest of the people.
8. Detroiters' homes being seized for \$600,000,000.00 property taxes not owed being made available to slum landlords for less than was legitimately owed in taxes.
9. Sambo Black churches, Council of Baptist Pastors and Vicinity, Civil Rights organizations such as NAACP and Former Mayor Coleman A Young appointees on the take or on their knees.

Alley Dust Up

2/15/2024

Vehicle has handicap plate and I late was going for a physical therapy appointment.

Spitefully (\$50.) unlawfully denied access to my garage entrance (**Any Moment Plumbing**)

Often my vehicle does not leave the garage for as many as three days.

My vehicle never left the garage for an entire week while work was taking place the previous week.

I do not park in the alley

I **only** use the alley to access my garage

Any Moment Plumbing worksite was more the 300 ft west of my garage entrance.

No City of Detroit identifying decals

No identifying barricades at either end of alleyway.

No **City of Detroit** or **Any Moment Plumbing** mail or door knock notices

I exited the east entrance of the alley, their worksite is **WEST** of my garage

My garage is "only accessible" through the alley entrance

Spitefully (\$50) and unnecessarily placed barricades in front of my garage door

Disrespectfully (see Old Black Bitch) refused to remove barricades blocking my garage entrance

Advised me to illegally park in my yard on unpaved surface

Failed to provide notice to home owners of closure order

I was illegally denied opportunity to contest **invisible** closure

I was call an "Old Black Bitch" by one of the white workers

I am **OLD**, 79 on my next birthday.

I am **BLACK**, would not have it any other way.

The "**BITCH**" part is debatable", depends on the circumstances; **this is the circumstance.**

Authorities, Black or white, always immediately assume if an uppity Black person and a white person have a dispute, the Black person is wrong. White Privilege

I demand a public apology from all parties, handicap accommodation (DO NOT SPITEFULLY BARRIADE MY GARAGE) and financial compensation.

Officer Peacock

Any Moment Plumbing

Officer Peacock refused request to allow me to complete parking vehicle in my garage until her supervisor was on site.

Officer Peacock never instructed that my garage access not be barricaded by racist white or Black workers - White Privilege

Issued 2 citations

(I did advise Officer Peacock that she might not want to ticket me.)

Driving in a construction zone

Disobey Lawful Order of a Police Officer

Supervisor On Duty

Approved Officer Peacocks' analysis of situation for citations.

Did not advise contractor not to barricade my garage door, White Privilege

Ombudsman Office (Ms McNeil)

Request was made to the Ombudsman Office form an onsite visit during the incident which lasted for 2 hours or more. No show or follow up.

Neighborhood Police Officer (Dale Dars (sic))

Responded to request for onsite visit.

Advised me that job would be finished the following day and to **just let it go**. White Privilege

Never advised contractors **not to barricade my garage door. White Privilege**
