RE: Request the Drafting of Childcare Impact Fund Ordinance

Councilwoman Calloway is proposing the adoption of a Childcare Impact Fund Ordinance in the City of Detroit, similar to San Francisco's Childcare in Lieu Ordinance (Ord. 150793). This ordinance aims to address the growing need for childcare facilities in our city by imposing Child Care Impact Fee Requirements on new office, residential, and hotel development projects.

**Background:** The City of Detroit has been experiencing a resurgence in development, particularly in the areas of office, residential, and hotel projects. While this growth is beneficial for the city's economy, it also brings about the need for increased childcare services to support the families of the individuals working and residing in these developments.

**Proposal:** The proposed Childcare Impact Fund Ordinance will require developers of new office, residential, and hotel projects to contribute to a fund dedicated to expanding access to quality childcare services in Detroit. The ordinance will include the following key provisions:

- 1. **Child Care Impact Fee Requirements:** Developers will be required to pay a fee based on the size and type of their projects. These fees will be used to support the development and maintenance of childcare facilities in the city.
- 2. **Exemptions and Waivers:** The ordinance will outline specific criteria for exemptions or waivers from the Child Care Impact Fee Requirements, taking into account the size and nature of the development projects.
- 3. **Fund Allocation:** The funds collected through the Child Care Impact Fees will be allocated to initiatives aimed at improving childcare accessibility and affordability in Detroit, including the construction of new childcare facilities, training and development programs for childcare providers, and subsidies for low-income families.
