Honorable City Council:

Council Councilmember Benson has requested that the Law Department prepare an ordinance to amend Chapter 5 of the 2019 Detroit City Code, *Amusements and Entertainments*, Article V, *Coffee Houses and Concert Cafes*, by amending Section 5, Division 5, Subsection 28, *expiration date and renewal requirements*, to all arcade licenses that are issued under this division shall expire on May 31st of each year. Previously, the license expired on April 30th of each year. This ordinance was prepared in conjunction with nine other ordinances, all related to the changing of the expiration date of licensing for various businesses. A copy of the ordinance which has been approved as to form is attached for your review and consideration.

6 IT IS HEREBY ORDAINED BY THE PEOPLE OF THE CITY OF DETROIT

7 THAT:

8 Section 1. Chapter 5 of the 2019 Detroit City Code, *Coffee Houses and Concert Cafés*,
9 Article V, Division 2, be amended by amending Section 5-5-28, to read as follows:

10 CHAPTER 5. AMUSEMENTS AND ENTERTAINMENTS

11 ARTICLE V. COFFEE HOUSES AND CONCERT CAFÉS

12 Sec. 5-5-28. Expiration and Renewal Dates for Coffee House Licenses.

13 (a) All coffee house licenses that are issued pursuant to this article shall expire on
14 ~~April 30th~~ May 31st of each year.

15 (b) A business license that is issued under this division for a coffee house shall remain
16 valid until the expiration date unless suspended or revoked in accordance with Chapter 28 of this
17 Code, *Licenses*.

18 (c) A business license that is issued under this division for a coffee house may be
19 renewed only by submitting a completed application and paying the required fee as provided for
20 in this division.

21 (d) All applications for renewal of a coffee house license that is issued under this
22 division shall be filed before ~~May 1st~~ June 1st of each year.

23 Sec. 5-5-29. Expiration and Renewal Dates for Concert Café Licenses.

1 (a) All concert café licenses shall be issued for a two-year period commencing on May 4st
2 31st in each even-numbered year and expiring on April 30th in the next even-numbered year.

3 (b) A business license that is issued under this division for a concert café shall remain valid
4 until the expiration date unless suspended or revoked in accordance with Chapter 28 of this Code,
5 *Licenses*.

6 (c) A business license that is issued under this division for a concert café may be renewed
7 only by submitting a completed application and paying the required fee as provided for in this
8 division.

9 (d) All applications for renewal of concert café licenses shall be filed before ~~May~~ June 1st
10 in each even-numbered year.

11 **Section 2.** This ordinance is hereby declared necessary to preserve the public peace, health,
12 safety, and welfare of the People of the City of Detroit.

13 **Section 3.** All ordinances, or parts of ordinances, that conflict with this ordinance are
14 repealed.

15 **Section 4.** In the event this ordinance is passed by two-thirds (2/3) majority of City Council
16 Members serving, it shall be given immediate effect and become effective upon publication in
17 accordance with Section 4-118 of the 2012 Detroit City Charter. Where this ordinance is passed
18 by less than a two-thirds (2/3) majority of City Council Members serving, it shall become effective
19 on the thirtieth (30) day after enactment, in accordance with Section 4-118 of the 2012 Detroit City
20 Charter.
