2 AN ORDINANCE TO AMEND Chapter 5 of the 2019 Detroit City Code, *Amusements*
3 *and Entertainments*, Article X, *Sexually-Oriented Businesses*, Division 2, *License*, by amending
4 Section 5-12-28, *Expiration Date and Renewal Requirements*, to change the expiration date of
5 licenses issued under the division to May 31st of each year.

6 IT IS HEREBY ORDAINED BY THE PEOPLE OF THE CITY OF DETROIT
7 THAT:

8 Section 1. Chapter 5 of the 2019 Detroit City Code, Public Dance Halls, Article X,
9 Division 2, be amended by amending Section 5-12-28, to read as follows:

10 CHAPTER 5. AMUSEMENTS AND ENTERTAINMENTS

11 ARTICLE XII. SEXUAL-ORIENTED BUSINESSES

12 Sec. 5-12-28. **Expiration Date and Renewal Requirements.**

13 (a) A business license shall expire on ~~April 30th~~ May 31st of each year.

14 (b) A business license shall remain valid until the expiration date unless suspended or
15 revoked in accordance with Chapter 28 of this Code, *Licenses*.

16 (c) A business license may be renewed only by submitting a completed application and
17 paying the required fee as provided for in this division.

18 (d) Applications for renewal of an annual business license, including the payment of
19 the application fee, should be made at least 60 days before the expiration date of the current annual
20 license, provided, that, where made less than 60 days before the expiration date, the expiration of
21 the current license will not be affected.

22 Section 2. This ordinance is hereby declared necessary to preserve the public peace, health,
23 safety, and welfare of the People of the City of Detroit.

1 **Section 3.** All ordinances, or parts of ordinances, that conflict with this ordinance are
2 repealed.

3 **Section 4.** In the event this ordinance is passed by two-thirds (2/3) majority of City Council
4 Members serving, it shall be given immediate effect and become effective upon publication in
5 accordance with Section 4-118 of the 2012 Detroit City Charter. Where this ordinance is passed
6 by less than a two-thirds (2/3) majority of City Council Members serving, it shall become effective
7 on the thirtieth (30) day after enactment, in accordance with Section 4-118 of the 2012 Detroit City
8 Charter.
