On April 16, 2024, a case evaluation panel evaluated the above-captioned lawsuit and awarded **Nineteen Thousand Dollars and NO/Cents (\$19,000**) in favor of the plaintiff. The parties have until May 14, 2024, to either accept or reject the case evaluation.

Based upon our review of the facts and particulars of this lawsuit, which are set forth in a confidential memorandum that is being separately hand-delivered to each member of Your Honorable Body, it is our considered opinion that a settlement in the amount of **Nineteen Thousand Dollars and NO/Cents (\$19,000.00)** is in the best interest of the City of Detroit.

We, therefore, request Your Honorable Body to authorize settlement of the above referenced lawsuit and to direct the Finance Director to issue a draft in that amount of (\$19,000.00) payable to Gregory Rogers and his attorneys, Detroit Justice Center, to be delivered upon receipt of properly a executed Release, Stipulation and Order of Dismissal entered in Wayne County Circuit Court Case No. 23-003029-CZ.
