RE: Request to accept an increase in appropriation for the FY 2024 Public Health Emergency Preparedness Grant and the FY 2024 Public Health Emergency Preparedness - Cities Readiness Initiatives Grant

The Michigan Department of Health and Human Services (MDHHS) has awarded an increase in appropriation to the City of Detroit Health Department for the FY 2024 Public Health Emergency Preparedness (PHEP) Grant, in the amount of \$68,498.00. MDHHS has also awarded an increase in appropriation to the Health Department for the FY 2024 PHEP - Cities Readiness Initiatives (CRI) Grant, in the amount of \$100,261.00.

The PHEP grant was approved by Council in the adopted budget. This funding will increase appropriation 21164 by \$24,137.00. This grant was previously approved in the amount of \$224,400.00, and will be increased to a total of \$248,537.00. The PHEP-CRI grant was also approved by Council in the adopted budget. This funding will increase appropriation 21165 by \$71,502.00. This grant was previously approved in the amount of \$255,000.00, and will be increased to a total of \$326,502.00.

The objective of the grants is to build Detroit public health emergency preparedness and response capacity and capability. The funding allotted to the department will be utilized to pay for staff salaries and contractual services.

I respectfully ask your approval to accept the increase in appropriation funding in accordance with the attached resolution.

- 1. The project manager will assign the agency users to any new Local Health Department 2024 projects.
- 2. For your convenience you can access the "Comprehensive Agreement Training for Grantee" material on the home page by clicking "About EGrAMS" and downloading the PDF. Access the system using the URL: https://egrams-mi.com/MDHHS/.
- 3. Login into MI E-Grants system.
- 4. Enter the application using the drop down menu's "Grantee>Grant Application>Enter Grant Application" and click on "Go".
- 5. Select the CO-2024/Local Health Department 2024 program and click the "Go" button.
- 6. Select the hyperlink titled "Local Health Department 2024".
- 7. Select hyperlink to various projects and amend the application sections. See page 59 for detailed instructions.
- 8. When the amended application has been entered, validated, and is error free it is ready for submission by the authorized official.

Select the Grant Program and click on the 'Find' button. Select the agreement from the dropdown menu located at the bottom of the screen. "Draft" is the pending amendment.
