Re: Fiscal Year 2021-2022 Budget Transfer Request – City Council Budget

Honorable Detroit City Council Members:

Under State of Michigan Public Act 2 of 1968 (the "Uniform Budgeting and Accounting Act") and the 2012 Detroit City Charter, the City cannot incur expenditures in an appropriation account in excess of the amount appropriated by the Detroit City Council. Under Section 8-211 of the 2012 Detroit City Charter, the Administration may propose the transfer of all or part of any unencumbered appropriation balance among the programs, services, or activities within an agency or from one agency to another, subject to City Council authorization.

The new City Council term is the first time a Council Member elected by district has been elected City Council President. Recognizing the additional responsibilities of that office, the City Council President has requested funding for her office equal to that of an At-Large Council Member. At-Large Council Members' budgets are currently \$93,325 larger than District Council Members' budgets. Given the change in Council President only covers half of the current fiscal year, the remaining budget difference this fiscal year would be half that amount (\$46,663). If approved, the attached resolution would transfer \$46,663 from the available balance in the prior District 7 Council Member's budget to the District 5 Council Member's budget. This does not impact the current District 7 Council Member's budget.

We respectfully request your approval of the attached resolution, with a waiver of reconsideration, to permit the requested appropriations transfer.
