## **RESOLUTION URGING THE MICHIGAN LEGISLATURE TO SUPPORT A SIGNIFICANT INCREASE IN FUNDING FOR MICHIGAN 2-1-1 IN THE FISCAL YEAR 2025 BUDGET**

- WHEREAS, Michigan 2-1-1 is a service that the United Way provides at no cost to Michigan residents, connecting them quickly, easily, and confidentially with thousands of health and human services agencies and resources right in their communities; 24 hours a day, 365 days a year via phone, email, live chat, and online databases; and
- WHEREAS, The United Way for Southeastern Michigan is the operator of Michigan 2-1-1 for Wayne, Oakland, Macomb, Washtenaw and Lapeer Counties; and
- **WHEREAS,** Michigan 2-1-1 has supported the City of Detroit during natural disasters, including regional flooding, power outages, extreme weather conditions and global crises, including providing information about COVID-19 testing and vaccination locations; and
- **WHEREAS,** At the start of the pandemic, the United Way's Asset Limited, Income Constrained, Employed (ALICE) report showed that 40% of the households in the region were already struggling to cover the cost of basic needs;<sup>1</sup> and
- **WHEREAS,** More than 60,000 individuals from the City of Detroit have contacted Michigan 2-1-1 for assistance with housing, utility costs, transportation, food, and other resources in the last year alone; and
- **WHEREAS,** The City of Detroit recognizes United Way for Southeastern Michigan's 2-1-1 service as an essential part of our human service infrastructure, connecting individuals and families in need with critical assistance in times of crisis; **NOW, THEREFORE BE IT**
- **RESOLVED,** That the Detroit City Council requests the Michigan Legislature to support an additional \$7 million in funding for Michigan 2-1-1 in the FY2025 budget; **BE IT FURTHER**
- **RESOLVED,** This increased investment will boost capacity, grow community awareness of 2-1-1, expand social navigation support, strengthen coordination with state and local governments, and ensure that the system is properly resourced to continue to provide this essential service for anyone who needs it at any time; **NOW BE IT FINALLY**
- **RESOLVED,** That the City Clerk forward copies of this resolution to the United Way for Southeastern Michigan and the Detroit Delegation in the Michigan Legislature.
