This correspondence will serve as the official Notice of Award for the project titled "**Neighborhood Wellness Centers with DHD**". Detroit Health Department, hereby referred to as the Local Health Department (LHD), is funded in the amount of \$976,610.00; intended to support partnership between the LHD and the Michigan Department of Health and Human Services to deliver preventative healthcare screenings and COVID-19 testing services at 7 Neighborhood Wellness Centers within the Detroit Health Department's jurisdiction. The project begins May 1, 2024, and will end September 30, 2024. With **funding currently set for one year, continuation of this program is possible if funds are available.**

The funding allocated is intended to address health disparities in the Detroit community by providing healthcare services, as well as DHD Programs' resources, in collaboration with MDHHS/Neighborhood Wellness Centers. This type of presence will allow DHD to lower barriers, fight disease, and promote health even further. DHD will offer services at the following 7 Neighborhood Wellness Centers:

- Bethel Baptist Church East
- Historic King Solomon Church
- The Open Door Church of God in Christ
- Wayne County Community College District Northwest Campus
- Southwestern Church of God
- Hartford Memorial Baptist Church
- Triumph Church

The Michigan Department of Health and Human Services (MDHHS) will require reporting of program measures, regular attendance at meetings, and other activities to support the implementation of program, evaluation and continued funding efforts. Program requirements are further outlined within Standard Operating Procedures (SOP) to be provided to the LHD prior to the start of program implementation. **The funding will be issued within the next iteration of the Comprehensive Agreement and MDHHS encourages the use of the staffing agencies through the <u>MI Deal</u> program.**
