On April 9, 2024 a case evaluation panel evaluated the above-captioned lawsuit and awarded **Eight Thousand Five Hundred Dollars and ^{NO}/Cents (\$8,500.00)** in favor of the plaintiff. The parties have until 5/7/2024 to either accept or reject the case evaluation.

Based upon our review of the facts and particulars of this lawsuit, which are set forth in a confidential memorandum that is being separately hand-delivered to each member of Your Honorable Body, it is our considered opinion that a settlement in the amount of **Eight Thousand Five Hundred Dollars and ^{NO}/Cents (\$8,500.00)** is in the best interest of the City of Detroit.

We therefore request Your Honorable Body to authorize settlement of the above referenced lawsuit and to direct the Finance Director to issue a draft in that amount of **Eight Thousand Five Hundred Dollars and ^{NO}/Cents (\$8,500.00)** payable to Peter Hirakis and THEIR attorneys, LeVasseur Dyer & Associates, to be delivered upon receipt of properly executed Releases, Stipulation and Order of Dismissal entered in Lawsuit No.23-000667-CH and, where deemed necessary by the Law Department a properly executed Medicare/CMS Final Demand Letter.
