Request:

The above recommendation is at the request of the General Services Department.

Rationale:

The above recommendation is based on the ability to attract and retain essential personnel in the General Services Department, and to create equality with related architecture roles within the city. The General Services Department submitted a request for job evaluation for several Landscape Architecture roles, indicating specifically that the Assistant Chiefs of Landscape Architecture within their group were completing tasks commensurate to those in the Planner IV - Landscape Architecture roles that reside in the Housing and Revitalization department.

The Classification and Compensation team conducted an onsite review of the job responsibilities for both the Assistant Chief of Landscape Architecture and the Planner IV - Landscape Architecture roles and confirmed that they were comparable. Additionally, the Assistant Chief of Landscape Architecture roles require that an individual must be a registered licensed architect in the state of Michigan. In light of these points, the Classification and Compensation team recommends that the pay range for Assistant Chief of Landscape Architecture be adjusted to mirror that of the Planner IV – Landscape Architecture.

The proposed pay ranges are based on the City of Detroit's ability to fund the increases and are subject to City Council approval.
