**RE: Authorization to submit a grant application to the U.S. Department of Transportation for the FY 2024 Active Transportation Infrastructure Investment Program (ATIIP) Grant**

The Department of Public Works, in partnership with the General Services Department, is hereby requesting authorization from Detroit City Council to submit a grant application to the U.S. Department of Transportation for the FY 2024 Active Transportation Infrastructure Investment Program (ATIIP) Grant. The amount being sought is \$10,500,000.00. The Federal share is 70 percent or \$10,500,000.00 of the requested amount and there is a required cash match of 30 percent or \$4,500,000.00. The total project cost is \$15,000,000.00. The match will be provided by an existing General Services Department Grant.

The FY 2024 Active Transportation Infrastructure Investment Program (ATIIP) Grant will enable the department to:

- Construct an off-street one-mile segment of the Joe Louis Greenway along a former rail corridor from Dequindre Street to Woodward Avenue.
- Install non-motorized path, underground utilities, lighting, and a non-motorized bridge over the Canadian National Railway.
- Remove blight and provide a safe, new off-street route for non-motorized users, connecting the cities of Detroit, Hamtramck and Highland Park.

If the application is approved, a cash match will be provided from appropriation 21241, which comes from the existing Michigan Enhancement Grant awarded by the Michigan Economic Development Corporation.

We respectfully request your approval to submit the grant application by adopting the attached resolution.
