

Wayne County awarded the City of Detroit General Services Department with the FY 2021-2022 Wayne County Parks Mileage Grant for a total of \$234,000.00. There is no match requirement. The total project cost is \$234,000.00. Detroit City Council approved the request to accept and appropriate this funding on October 25, 2022. This request is to execute a grant amendment for a time extension to the project period. Wayne County requires council authorization to execute this grant agreement amendment. The original grant end date was September 30, 2024. The grant amount will not change. If approval is granted, the grant end date will be extended to September 30, 2025.



WHEREAS, the General Services Department is requesting authorization to accept a time-extension for a grant of reimbursement from Wayne County, awarded in the amount of \$234,000.00, to make improvements to various parks in the City of Detroit; and

WHEREAS, Detroit City Council approved the request to accept and appropriate this funding on October 25, 2022, and this request is to execute a grant amendment for a time extension to the project period; Wayne County requires council authorization to execute this grant agreement amendment; and

WHEREAS, the original grant end date was September 30, 2024; and the grant end date will be extended to September 30, 2025; and

WHEREAS, the Law Department has approved the attached agreement amendment as to form; now

THEREFORE, BE IT RESOLVED that the Mayor is authorized to execute the grant amendment on behalf of the City of Detroit, for a time extension to the project period, for the FY 2021-2022 Wayne County Parks Mileage Grant.

AMENDMENT NO. 1 TO THE AGREEMENT BETWEEN
THE COUNTY OF WAYNE AND THE CITY OF DETROIT

THIS AMENDMENT is made by and between the County of Wayne, Michigan, a body corporate and Charter County acting through its Department of Public Services (“County”), and the City of Detroit, a Michigan municipal corporation (“City”), and modifies the intergovernmental agreement for the 2021-2022 park millage allocation for improvements to Sasser, Three Mile Park, Crockett, Voigt Park, Van Antwerp Park, Rouge Park and Kelley Playground, approved by the Wayne County Commission on April 11, 2023 by Resolution No. 2023-235 (“Agreement”).

WHEREAS, the parties wish to extend the Agreement term to end on September 30, 2025 (from September 30, 2024) to provide for the completion of the improvements at the above-referenced parks and to change the scope of the Project at Van Antwerp Park.

NOW, THEREFORE, it is mutually agreed by and between the parties hereto as follows:

1. The termination date described in Section 3.01 of the Agreement shall be modified from “September 30, 2024” to “September 30, 2025”.
2. Exhibit B attached to the Agreement shall be amended to change the Project description for Van Antwerp Park from ball field improvements to park amenities, including picnic tables and shelter amenities.
3. All other terms and conditions in the Agreement shall remain in full force and effect.
4. This Amendment is subject to the County’s policies regarding modification of agreements.
5. Each party warrants that the person signing this Amendment is authorized to sign on behalf of its principal and is empowered to bind its principal to this Amendment.
