Per Section 43-3-53 or 43-3-62 of the Detroit City Code, the Historic Designation Advisory Board (HDAB) mailed requests for comment notifications to property owners and residents within 300 feet of *nine newly proposed locations* for Secondary Street Signs. Comment notifications also were sent to the Detroit Fire Department, Detroit Police Department Precinct Stations, Detroit Department of Public Works and the United States Postal Service. Recipients had twenty-one (21) days from the receipt of notice to submit comments or objections on a requested Secondary Street Sign location for the 2024 application cycle.

Additionally, Section 43-3-63(c) provides:

Upon expiration of the 21-day comment period, the Legislative Policy Division shall make a written report summarizing the comments and objections, if any, regarding the request, and forward the report to the City Council.
