## RESOLUTION


<b>COUNCIL MEMBER</b>

WHEREAS the 10' wide underground electrical easement for service and equipment will provide electrical power to a new football dome located in the park.

## THEREFORE, BE IT:

**RESOLVED,** the Detroit City Council authorizes a DTE Electric Company a 10' underground electric easement at Chandler Park 12700 Harper Detroit, MI 48213 to enable electrical service at the new football dome.

THE CENTERLINE OF A 10' WIDE EASEMENT FOR UNDERGROUND ELECTRIC AND ELECTRICAL EQUIPMENT, BEING A PART OF PRIVATE CLAIM 322, CITY OF DETROIT, WAYNE COUNTY, MICHIGAN DESCRIBED AS:

COMMENCING AT THE NORTHWEST CORNER OF SAID PRIVATE CLAIM 322; THENCE ALONG THE WEST LINE OF SAID PRIVATE CLAIM 322, S27'08'47"E, 2261.23 FEET; THENCE, N56'59'42"E, 154.83 FEET TO THE POINT OF BEGINNING OF SAID CENTERLINE; THENCE, ALONG SAID CENTERLINE, S76'18'09"E, 176.73 FEET; THENCE, S30'05'08"E, 85.12 FEET TO THE POINT OF ENDING OF SAID CENTERLINE.
