RE: Request for Public Hearing to Establish a Plant Rehabilitation District on behalf of Old St. Jean Properties, LLC in the general area of 521 Old Saint Jean, Detroit, Michigan, in accordance with Public Act 198 of 1974. (Petition # 2024-226)

The Housing and Revitalization Department has reviewed the application of **Old Saint Jean Properties**, **LLC** and find that it satisfies the criteria set forth by P.A. 198 of 1974 and would be consistent with development and economic goals of the Master Plan.

WHEREAS, Act 198 requires that prior to the adoption of an Plant Rehabilitation District, City Council shall provide an written notice to the owners of all real property within the proposed industrial development district and shall hold a public hearing on the establishment of the industrial development district at which time those owners and other residents or taxpayer of the City of Detroit shall have a right to appear and be heard on the matter;
