We have reviewed the above-captioned lawsuit, the facts and particulars of which are set forth in a confidential memorandum that is being separately hand-delivered to each member of Your Honorable Body. From this review, it is our considered opinion that a settlement in the amount of **Twenty-Two Thousand Five Hundred Dollars and NO/Cents (\$22,500)** is in the best interest of the City of Detroit.

We, therefore, request authorization to settle this matter in the amount of **Twenty-Two Thousand Five Hundred Dollars and NO/Cents (\$22,500)** and that Your Honorable Body direct the Finance Director to issue two drafts. One draft in the amount of Seventeen Thousand Five Hundred Dollars payable to Shaniqua Deisch and **Her** attorney, Law Offices of Elias Muawad, P.C., and the second draft in the amount of Fifteen Thousand Dollars payable to Robbie Deisch and **Her** attorney, Law Offices of Elias Muawad, P.C., to be delivered upon receipt of properly executed Releases and Stipulation and Order of Dismissal entered in Lawsuit No.23-016105-NF, approved by the Law Department.
