The Michigan Department of Health and Human Services (MDHHS) has awarded an increase in appropriation to the City of Detroit Health Department for the FY 2025 Neighborhood Wellness Centers Grant, in the amount of \$253,091.00. This funding will increase appropriation 21423, previously approved in the amount of \$976,610.00, by council on September 10, 2024, to a total of \$1,229,701.00.
