RESOLUTION IN SUPPORT OF THE SAFER MICHIGAN ACT

- WHEREAS,** Every year more than 4,500 returning citizens re-enter our Michigan communities from the Michigan Department of Corrections; and
- WHEREAS,** All Michigan residents have a vested interest to ensure that returning citizens have made positive steps toward self-improvement that will allow them to smoothly transition back into society while also reducing the likelihood of repeat offenses; and
- WHEREAS,** The Michigan Legislature has introduced a package of bills known as the “Safer Michigan Act,”¹ which will provide opportunities for people in prison to earn credits to reduce their sentences except for those convicted of the most serious crimes; and
- WHEREAS,** Research has consistently found that providing incentives for rehabilitation reduces recidivism and decreases crime, and that drug treatment, educational programs, vocational training, and other forms of in-prison programming all reduce recidivism and improve outcomes post-release according to the National Academies of Science; and
- WHEREAS,** The Safer Michigan Act prioritizes the safety of victims of crime, and provides certainty about how long individuals will spend in prison by informing victims of how much time a defendant will have to serve if they complete programs and earn productivity credits and by providing notification of any parole; and
- WHEREAS,** Michigan voters overwhelmingly, including victims of crime, support legislation that prioritizes the rehabilitation of incarcerated individuals with the hope that returning citizens have been prepared to reenter their communities with the best possible chance to succeed; and
- WHEREAS,** If Michigan adopts a productivity credit policy, it will join at least 35 other states that provide opportunities for people in prison to earn credits to reduce their sentences by completing programming; and
- WHEREAS,** The Detroit City Council remains committed to addressing the effects of crime in Detroit, both by protecting victims and by supporting returning citizens’ ability to become productive and successful community members upon their return; **NOW THEREFORE BE IT**
- RESOLVED,** The Detroit City Council strongly urges the Michigan legislature to pass Michigan House Bills 4450-4453 and Senate Bills 861-864, known as the Safer Michigan Act; **NOW BE IT FINALLY**
- RESOLVED,** That the Detroit City Clerk provide a copy of this resolution to the Mayor, to the Detroit delegations of both the Michigan State House and Senate, and to Governor Gretchen Whitmer.
