RE: Request to Accept and Appropriate the FY24 Lead-Based Paint Hazard Reduction Program

Honorable City Council:

Through the U. S. Department of Housing and Urban Development's (HUD) Office of Lead Hazard Control and Healthy Homes (OLHCHH), the City of Detroit was awarded \$7.75 million for the FY24 Lead-Based Paint Hazard Reduction Program (FY24 LHR). HUD is providing the funding to help grantees protect children and families from lead-based paint hazards and additional home health hazards. The grant dollars will be used to identify and address dangerous lead in low-income families' older homes.

The City's FY24 LHR Grant is comprised of \$7,000,000 in LHR funding and \$750,000 in Healthy Homes Supplemental funding with a match commitment of \$1,120,000 coming from Appropriation #10409. The funding will allow the City to continue to address lead-based paint hazards and housing related health and safety hazards in homes where eligible families live. The funding will help families, especially children, to be healthier and improve their futures.

If approval is granted to accept and appropriate this funding, the appropriation number is 21495 - FY24 Lead Hazard Reduction Grant.

The Housing & Revitalization Department hereby requests this Honorable Body's authorization to accept and appropriate this grant by supporting the attached resolution.
