BETWEEN

This Memorandum of Understanding ("MOU") is entered into by and between the DETROIT PUBLIC SAFETY FOUNDATION (DPSF), a Michigan non-profit corporation, located at 1301 Third St., Detroit, Michigan 48226, ("Beneficiary"), and VISIT DETROIT, a Michigan not-for-profit organization, located at 211 W. Fort St., Detroit, Michigan 48226. The Donor and Beneficiary may each be referred to herein as a "Donor" or collectively as the "Beneficiary" to this MOU, as applicable.

RECITALS

Whereas, the Beneficiary has been awarded a donation in the cumulative amount of One Hundred Thousand Dollars (\$100,000) ("Donation") from Visit Detroit for the purpose of supporting the Detroit Fire Department and the Detroit Police Department each in amounts of \$50,000.

Whereas, the Donation is to be used as directed by leadership of the Detroit Police, Fire and Beneficiary where the need is greatest during large events that require support outside of current city budgeted needs.

Whereas, the Beneficiary is to serve as the fiscal sponsor of the Funds for Purchases;
