RE: Request to Accept an Increase in Appropriation for the FY 2025 Oral Health Kindergarten Assessment Program Grant

The Michigan Department of Health and Human Services (MDHHS) has awarded an increase in appropriation to the City of Detroit Health Department for the FY 2025 Oral Health Kindergarten Assessment Program Grant, in the amount of \$49,144.00. There is no match requirement for this grant. The grant was adopted in the FY 2025 budget in the amount of \$104,040.00. We are requesting to increase appropriation 21340, in the amount of \$40,798.00, to reflect the total project cost of \$144,838.00.

The objective of the grant is to ensure that kindergarten or first grade students entering school in Michigan have a dental oral health assessment prior to enrollment. The funding allotted to the department will be utilized to perform no-cost oral health assessments on children enrolling into kindergarten or first grade in the City of Detroit.
