We have reviewed the above-captioned lawsuit, the facts and particulars of which are set forth in a confidential memorandum that is being separately hand-delivered to each member of Your Honorable Body. From this review, it is our considered opinion that a settlement in the amount of **Thirty-Two Thousand Five Hundred Dollars and NO/Cents (\$32,500.00)** is in the best interest of the City of Detroit.

We, therefore, request authorization to settle this matter in the amount of **Thirty-Two Thousand Five Hundred Dollars and NO/Cents (\$32,500.00)** and that Your Honorable Body direct the Finance Director to issue **two** drafts: one draft in the amount of Seventeen Thousand Five Hundred Dollars payable to Shaniqua Deisch and her attorney, Law Offices of Elias Muawad, P.C., and the second draft in the amount of Fifteen Thousand Dollars payable to Robbie Deisch and her attorney, Law Offices of Elias Muawad, P.C., to be delivered upon receipt of properly executed Releases and Stipulation and Order of Dismissal entered in Lawsuit No.23-016105-NF, approved by the Law Department.
