

To Whom it May Concern:

Lambrecht Jerant, Inc. d.b.a. Bookies Bar & Grille is planning our annual Opening Day Tigers Party for April 4, 2025 which will be hosted in our private lot located at 2214 Cass Avenue, Detroit, MI, which is an adjacent parcel to our restaurant located at 2208 Cass Avenue, Detroit.

This is essentially the same set up that we have had for the past 15 years prior that we have done for Opening Day, Final Four Host Bar, and other major Downtown Detroit Sporting/Special Events.

This lot is secured with permanent and temporary fencing with a minimal two means of egress. A temporary tent (80'x40') is set up and is secured by weighted cement blocks. We have private security monitoring the premise, six dedicated for this outdoor area. Two security guards are located at the front door checking ID (event 21+), one at each means of egress, and two floating. We bring in a total of 14 porta potties, 12 set up for guests, two of which are ADA compliant, and we have two set up for our employees. Between 1pm-2pm, we do have them cleaned by the company which includes pump out and restocking of supplies. Our staff know to call 911 in the event of an emergency. We have a fire station located just one block away, and thankfully have not needed to call them for any of our special events.

We have an all staff meeting on April 3, 2025 that will bring all employees up to date on all aspects of the operation that day.
