The amount being sought is \$2,196,309.00. There is no City match requirement. The total project cost is \$2,196,309.00.

The FY 2025 Safe Routes to School Grant will enable the department to:

- Improve infrastructure conditions (including sidewalks repairs, crosswalk updates, signage updates, and ADA ramps) surrounding various elementary schools and provide safe walking, biking, and driving conditions for elementary, middle school, and high school students and the surrounding public
- Improve safety at the following schools: Davison Elementary, Gardner Elementary, Keidan Education Center, Mann Elementary, Osborn Highschool, Thirkell Elementary-Middle School, and Thurgood Marshall Elementary-Middle School

If awarded, the Department of Public Works City Engineer will be the project lead for this grant; and the planned improvements will be maintained by the Department of Public Works.

WHEREAS, all contingency costs have been accounted for in accordance with the Safe Routes to School (SRTS) Application Requirements and are included in the proposed total construction cost, which is \$2,196,309.00; and

WHEREAS, if awarded, the Department of Public Works City Engineer will be the project lead for this grant; and the Director of the Department of Public Works is authorized to execute a grant agreement on behalf of the City of Detroit and will serve as the authorized official for this grant project; now

THEREFORE, BE IT RESOLVED, the Department of Public Works is hereby authorized to submit a grant application to the Michigan Department of Transportation for the FY 2025 Safe Routes to School Grant.
