RE: Property Sale of 7619 & 7639 Mack, Detroit, MI 48214 (w/ restrictive covenant)

Honorable City Council:

The City of Detroit, Planning and Development Department (“P&DD”) has received an offer from Detroit Hurley LLC (the “Purchaser”), to purchase certain City-owned real property 7619 & 7639 Mack, Detroit, MI 48214 (the “Property”) for the purchase price of Sixteen Thousand Five Hundred and 00/100 Dollars (\$16,500.00).

The Purchaser recently acquired the adjacent building at 7637 Mack. The Purchaser is currently renovating their property into retail space for their business, Fungi and Fungal. The Purchaser proposes to use the Property for a covered outdoor retail space and green space. The Property is within a B4 zoning district (General Business District). The Purchaser’s proposed use of the Property is by-right and will be consistent with the allowable uses for which the Property is zoned.

We request that your Honorable Body adopt the attached resolution to authorize the Director of P&DD to execute a quit claim deed and such other documents as may be necessary or convenient to effect a transfer of the Properties by the City to the Purchaser.

RESOLUTION

BY COUNCIL MEMBER _____

NOW, THEREFORE, BE IT RESOLVED, that Detroit City Council hereby approves of the sale of certain real property at 7619 & 7639 Mack, Detroit, MI 48214 (the "Properties"), as more particularly described in the attached Exhibit A incorporated herein, to Detroit Hurley LLC (the "Purchaser"), for the total purchase price of Sixteen Thousand Five Hundred and 00/100 Dollars (\$16,500.00); and be it further

RESOLVED, that the Director of the Planning and Development Department, or his authorized designee, is authorized to execute a quit claim deed subject to a certain restrictive covenant as described in the Purchase Agreement between the Planning and Development Department and Purchaser, and other such documents necessary or convenient to effect transfer of the Properties to Purchaser consistent with this resolution; and be it further

RESOLVED, that the following Property Sales Services Fees be paid from the sale proceeds pursuant to the City's Property Management Agreement with the Detroit Building Authority ("DBA"): 1) Two Thousand Five Hundred and 00/100 Dollars (\$2,500.00) shall be paid to the DBA from the sale proceeds, 2) Eight Hundred Twenty-Five and 00/100 Dollars (\$825.00) shall be paid to the DBA's real estate brokerage firm from the sale proceeds and 3) customary closing costs up to Two Hundred and 00/100 Dollars (\$200.00) as well as any taxes and assessments which have become a lien on the Property; and be it further

RESOLVED, that the P&DD Director, or his authorized designee, is authorized to execute any required instruments to make and incorporate technical amendments or changes to the quit claim deed (including but not limited to corrections to or confirmations of legal descriptions, or timing of tender of possession of particular parcels) in the event that changes are required to correct minor inaccuracies or are required due to unforeseen circumstances or technical matters that may arise prior to the conveyance of the Property, provided that the changes do not materially alter the substance or terms of the transfer and sale; and be it finally

RESOLVED, that the quit claim deed will be considered confirmed when executed by the P&DD Director, or his authorized designee, and approved by the Corporation Counsel as to form.
