From this review, it is our considered opinion that a settlement in the amount of **Sixty Two Thousand Five Hundred Dollars and ^{NO}/Cents (\$62,500)** is in the best interest of the City of Detroit.

We, therefore, request authorization to settle this matter in the amount of **Sixty Two Thousand Five Hundred Dollars and ^{NO}/Cents (\$62,500)** and that Your Honorable Body direct the Finance Director to issue a draft in the amount of \$25,000.00 payable to **Aaron Baker** and his attorney, **Reifman Law Firm. PLLC**, and a draft in the amount of \$37,500.00 payable to **Cortez Robertson** and his attorney, **Dionne Webster- Cox** to be delivered upon receipt of properly executed Releases and Stipulation and Order of Dismissal entered in Lawsuit No..23-003850-NI, approved by the Law Department.
