On March 26, 2025, the parties agreed to settle the above-captioned Claim in the amount of **EIGHTY THOUSAND DOLLARS and ^{NO}/Cents** (**\$80,000.00**) in favor of the Claimant.

Based upon our review of the facts and particulars of this potential Claim, which is set forth in a confidential memorandum that is being separately hand-delivered to each member of Your Honorable Body, it is our considered opinion that settlement of this claim is in the best interest of the City of Detroit.
