The DBA has managed multi million capital projects like the Detroit Public Safety Headquarters, the Jason Hargrove Transit Center, and the under construction New Coolidge Bus Operations & Maintenance Facility.

Major capital projects take longer to develop and require the development of a construction budget through programing and preconstruction services working with the Department and Finance for the delivery of the project according to the source of funds (i.e. Federal, Bonds, State, City, etc.).
