From this review, it is our considered opinion that a settlement in the amount of **One Hundred Twenty Five Thousand Nine Hundred Sixty Five Dollars and** ⁴³/Cents (\$125,965.43) is in the best interest of the City of Detroit.

We, therefore, request authorization to settle this matter in the amount of **One Hundred Twenty Five Thousand Nine Hundred Sixty Five Dollars and** ⁴³/**Cents** (**\$125,965.43**) and that Your Honorable Body direct the Finance Director to issue a draft in that amount payable to Step by Step Physical Therapy and their attorney, Azzo Law, PLLC, to be delivered upon receipt of properly executed Releases and Stipulation and Order of Dismissal entered in Lawsuit No. 24-003815-NF, approved by the Law Department.
