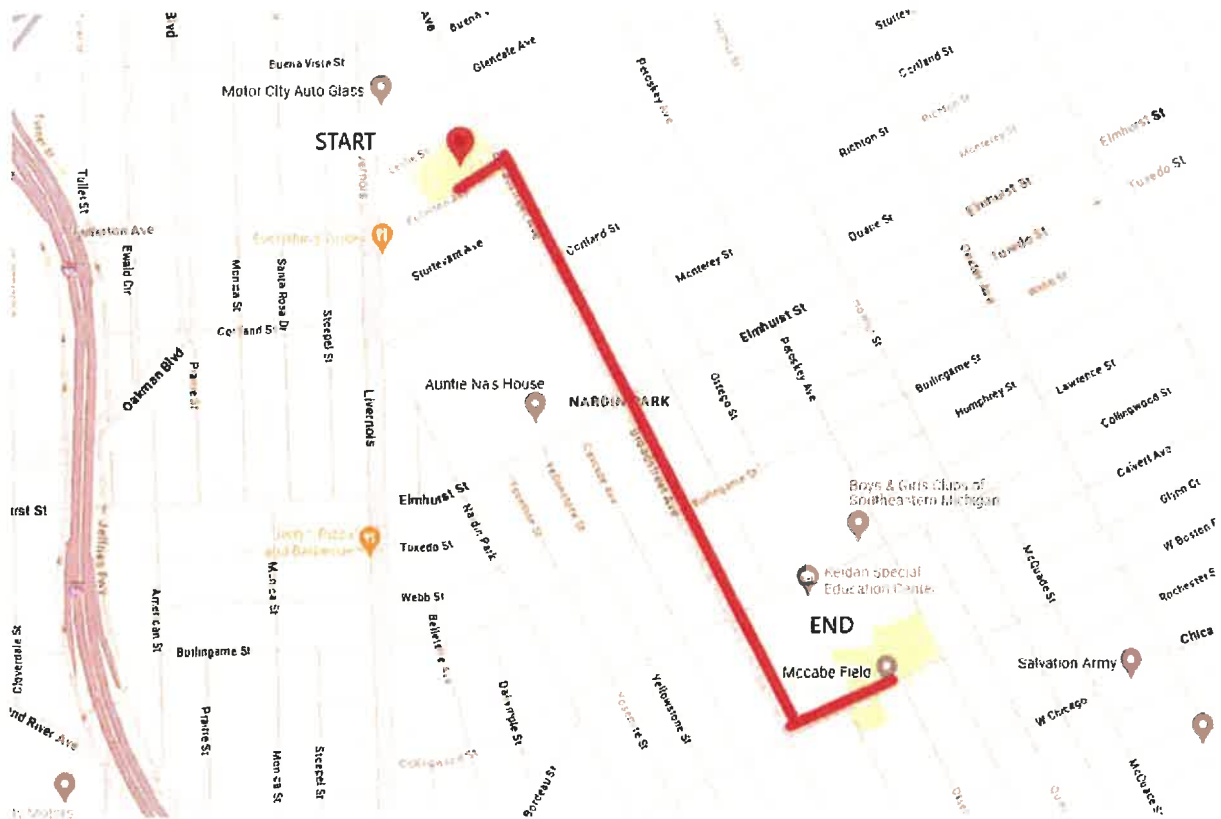

Barney McCosky Baseball/Basketball League Baseball Season Kick-off Parade and Battle of the Bands Parade Route and Maintaining of Traffic Plan



Red line indicates parade route and beginning/end of street closures.

Line up will begin at Fullerton and Broadstreet (Russell Woods Park). The procession will travel south down Broadstreet turn east at West Boston Boulevard, and end at McCabe Field. None of the streets slated for closure are major roadways, are all residential, and will be closed for the least amount of time possible to ensure minimal disruption to residents. Any traffic during this time can be rerouted to Petoskey Avenue or Livernois Avenue north and south

The Barney McCosky parade has been held regularly for over 30 years. Security has always been provided by the local police department. We have contacted the 10th precinct and confirmed they are willing to provide the necessary security and road closures for the duration of the actual parade. They provide a rolling baracade and only block off the necessary streets as the parade is moving. Once the parade is finished, an officer is stationed at the final location for the duration of the "battle of the bands". They have been notified of our dates, times, and location as well as the parade route. The department is waiting for confirmation from the necessary city offices.

The clean up plan for this parade is the same as it has been for years. We ensure nothing is left along the parade route and clean the end location with organization manpower and the help of volunteers.
