On March 21, 2024, your Honorable Body adopted a resolution authorizing payment of in the amount of **TWENTY THOUSAND, SEVEN HUNDRED AND TWENTY-FOUR DOLLARS and ^{NO}/Cents (\$20,724.00)** to settle the first-party PIP claim of Michigan Ambulatory Surgical Center (Jesse Lykes). However, the recommended settlement amount was incorrect. The correct amount of the settlement is **TWENTY-THREE THOUSAND, SEVEN HUNDRED AND TWENTY-FOUR DOLLARS and ^{NO}/Cents (\$23,724.00).**
