MOTION

Upon the recommendation of Marqaicha Welch, Procurement Manager, The Board of Water Commissioners for the City of Detroit, Water and Sewerage Department authorizes the Director to approve DWSD Contract 6007107 with the US Army Corps of Engineers, for the Design and Construction Assistance for the Detroit Lead Service Line Cutting Project, for a 25% percent cost to DWSD for a total contract amount not-to-exceed \$1,000,000.00 and a term of one year, through 6/30/26. This also authorizes the Director to take such other action as may be necessary to accomplish the intent of this vote.

BACKGROUND

File Number: 2025-78

There are over 50,000 properties in the City of Detroit where a structure has been demolished. Historically, the lead service line at demolished properties remained connected to the water main, was cut at the structure, "crimped" at the cut, and then left in the ground.

To protect public health and to comply with both state and federal lead and copper rules, abandoned lead lines must be cut at the corporation stop to ensure there is never a backflow or surge of potentially lead-tainted water from the abandoned lead lines into the public water system. The corporation stop is located at the main within the city's right of way, primarily in the street or the berm. (See graphic at right)

The United States Army's authority to provide design and construction assistance to cut lead service lines from the main is through Section 219 (f) (157) of the Water Resources Development Act of 1992, Public Law 102-580, as amended (hereinafter "Section 219"). Section 219 allows the Army Corps to assist non-federal entities in carrying out water-related environmental infrastructure projects, including design and planning assistance for projects like wastewater treatment facilities, water supply systems, and related resource protection initiatives; essentially allowing the Corps to help local communities with environmental infrastructure development through technical support and design work.

JUSTIFICATION FOR THIS AGREEMENT

Highlights of this proposed agreement include:

- 1. Detroit Water and Sewerage Department will provide GIS mapping that overlaps the list of demolished homes with its current lead service line inventory to identify worksites.
- 2. U.S. Army Corps will:
 - a. Conduct preliminary planning, including site assessment, obtaining all permits and approvals, and locating utilities.
 - b. Prepare the site, excavate the ground to expose the corporation stop, and perform required shoring and trenching activities.
 - c. Expose the lead service line at the point of connection to the water main. Use appropriate cutting tools to serve the lead service line as close as possible to the existing corporation stop.
 - d. Backfill and restore the site.
 - e. Document the entire process, including photographs, permits, inspection reports, and other relevant records.
- 3. Project to begin during 2026 construction season.
- 4. We anticipate 1,500 lines can be removed from the DWSD lead line inventory with the first funding increment.

PROCUREMENT METHOD

The U.S. Army Corps of Engineers will handle the procurement process and select contractors.

BUDGET

File Number: 2025-78

Construction costs for the initial increment of work are projected to be \$4,000,000, with the amount of Federal funds available for the work limited to \$3,000,000. DWSD's share of construction costs for the initial increment of work is projected to be \$1,000,000. Increments in work going forward will share costs at 75% Federal and 25% DWSD. Additional funds can be added to the project/this agreement. For new increments, DWSD and the City will need to coordinate through the Congressionally Directed Spending/Community Project Funding process.

The contract agreement was requested through Requisition #531610. The contract was procured as a single source, exception to competitive solicitation due to the joint agreement between the US Army Corps and DWSD. The agreement is terminated when there is no funding for further increments.

LETTER REPORT JULY 2024

- 1. SPONSOR: The non-Federal sponsors are the City of Detroit Water and Sewerage Department (DWSD), which is a local utility located in Wayne County, Michigan and the City of Detroit, Michigan. See Attachment #1 for a map of project location.
- 2. FINANCIAL CAPABILITY OF SPONSOR: The DWSD and the City of Detroit understand they are required to provide 25 percent of the cost for the project. The DWSD and the City of Detroit will provide self-certification of financial capability prior to execution of the Project Partnership Agreement.
- 3. DESCRIPTION OF THE PROJECT: The scope of the project involves cutting and capping the existing lead lines from previously demolished properties in various neighborhoods located in the City of Detroit.
- 4. ENVIRONMENTAL COMPLIANCE: Pursuant to the National Environmental Policy Act, the District shall develop and coordinate an Environmental Assessment (EA). If the public review of the EA indicates the project would not result in significant impacts on the quality of the human environment, then a Finding of No Significant Impact (FONSI) could be signed. If the EA reveals that there may be significant impacts on the quality of the human environment, then an Environmental Impact Statement (EIS) would be required.
- 5. COST: Total project costs are estimated at \$4,000,000.00. The project is cost shared 75 % Federal and 25% non-Federal. The Federal share is \$3,000,000.00. The non-Federal share of \$1,000,000.00 is being provided by the DWSD.


