**RE: Emergency Action Plan** 

Attached is our Emergency Action Plan for our **4th Annual Juneteenth Celebration** that will be held on **Saturday, June 14, 2025,** from 2 pm to 6pm. This event will be held outdoors in front of **SHAR Academy**, 1851 W. Grand Blvd, Detroit 48208. The streets will be blocked off between Scovel and Moore Street. The facilities on both sides of the street are owned and operated by SHAR, with an onsite medical department, fire alarm systems, and related emergency action and evacuation plans, as appropriate.

SHAR is always concerned with the safety and wellbeing of all of our employees, clients, visitors and other who may come to our facilities, or attend our events. Relative to the Juneteenth event

In addition, we have primary and secondary evacuation routes at Moore and Scovel Streets. Prior to the event these routes will be posted with assembly points. In the case of this type of public safety issues - they will be handled by the Wayne County Sheriff detail. Medical issues will be addressed by Hart EMS who we have contracted. In addition, there will be a first aid station located on the event site manned by trained, licensed SHAR nursing staff. There will be a PA system available for announcement of any emergencies and the like. Reporting of emergencies/fires/occurrences will be followed by SHAR's standard operating procedures. Documentation of SHAR personnel information is kept in Human Resources, and policies and procedures are updated annually as a requirement of SHAR's licensing and accreditation. Board approval is also required.

Attached is a site plan specifying the specific details, placement and location of particulars. If other information is needed, feel free to reach out to me or Ms. Scott as Event Coordinators.


