I, Denise Boyce-Hardison the undersigned, respectfully submit this petition to formally request reinstatement of contract 6004598 for Police Authorized Towing Services for the city of Detroit. This request is based on my prior contractual relationship with the City of Detroit, under which I was actively engaged in towing services until my contract was terminated on May 15, 2025 for excepting a call from an officer who stated the system was down and he had to give my company a call over the phone.

Bobby's TCB Towing Services Inc has provided police authorized towing service for the Detroit Police Department for over 25 years. During that time, my company has worked to fulfill the terms of the towing permits and later the towing contracts without any incidents and never once being named in any scandal. Bobby's TCB Towing Service Inc also recently was issued a Notice of intent to award the 2024 RFP# 184940- an opportunity that was rescinded due to the same isolated incident.

The termination of this contract has had a severe impact as it represents 85% of our business. The loss of this contract threatens not only the survival of the company but also the livelihood of our dedicated employees.


