Southwest Detroit Environmental Vision has awarded an increase in appropriation to the City of Detroit General Services Department for the sub-award from the Reducing Emissions from Diesel – Helping Eliminate Asthma in Detroit Grant, in the amount of \$56,996.71. This funding will increase appropriation 21093, previously approved in the amount of \$258,750.00, by council on May 17, 2022, to a total of \$315,746.71.
