RE: Request to Accept and Appropriate the State of Michigan FY 2024 Early Voting Grant

The Michigan Department of State and the Bureau of Elections have awarded the City of Detroit Clerks Office with funding included in the FY 2024 State budget for the explicit purpose for the implementation and execution of early voting. The total amount being received from the State is \$450,581.55. There is no match requirement. The total allowable project cost to be reimbursed is \$450,581.55.

The objective of the grant is to aid local jurisdictions with the implementation of early voting. The funding allotted to the department will be utilized to pay for early voting wage reimbursements for August & November 2024. This is a reimbursement program.

If approval is granted to accept and appropriate this funding, the appropriation number is 21535.

Thanks for hoping on the call to discuss the attached.

A quick recap of our meeting & next steps. As you can see below, we received \$1,169,504.17 from Wayne County a few months ago. It appears Rissa has identified part of that payment to include Christian's election workers reimbursement as part of a State program. As required by the program, the County submitted on our behalf, two reimbursement requests totaling \$459,124.65 (attached). I don't know what supporting material came with the \$1.1 million payment from the County, but it was determined that \$321,659.55 was to be deposited for Elections.

I just need to verify that dollar value before I can submit a request to Council to accept that money as there's a difference of \$137,465.10 in the documentation I currently have. Appreciate your efforts. Would be happy to set up a quick call with Regina or whomever once you've had time to discuss with them.
