LAWSUIT SETTLEMENT MEMORANDUM

City of Detroit v. v Detroit Police Officers Association and Detroit Fire Fighters Association; Case Number 24-005523-CZ

<u>SUBJECT MATTER OF LAWSUITS</u>: The Detroit Police Officers Association submitted a request under the Freedom of Information Act seeking information pertaining to the health, insurance and prescription information for all employees of the City of Detroit. The City of Detroit filed a Complaint for declaratory judgment prohibiting the turnover of information the City of Detroit deems private and protected from disclosure.

FACTS:

On or about March 21, 2025, the Detroit Police Officers Association submitted a request under the Freedom of Information Act seeking information and data regarding the medical, prescription and insurance information of all employees in the City of Detroit. The Detroit Police Officers Association asserts that it needs the information in order to informatively negotiate its Collective Bargaining Agreement with the City of Detroit. The City of Detroit denied the request due to the protected and private information sought by the request. Further, based on a similar issue having occurred between the parties, The City of Detroit filed a Complaint for declaratory judgment seeking to prohibit the turnover the information requested.

LIABILITY/EVALUATION:

The City of Detroit filed a lawsuit against the Detroit Police Officers Association asserting its request for medical, prescription and health insurance data violated the Health Insurance Portability and Accountability Act, and is exempted by the Freedom of Information Act. In a similar matter brought by the Detroit Police Officers Association, Judge Kathleen McCarthy, case number 22-09666-CZ, ordered the turnover of similarly sought information and ordered attorney fees to be paid to counsel for the Detroit Police Officers Association. That matter is currently under

appeal. The instant matter was reassigned to Judge McCarthy, allowing her to issue a similar order

in the instant matter.

While the City of Detroit is confident in its position, in order to avoid the fines and fees as

previously ordered, the parties have agreed to settle the matter. The terms of the proposed SA are

set forth in the proposed Resolution submitted herewith under separate cover. The SA will resolve

the case and essential terms of the SA are:

The City of Detroit will pay Three Hundred Thirty-Five Thousand Ninety-Three Dollars and 1.

13/100 (\$335,093.13) to the Detroit Police Officers Association, which represents previously

ordered attorney fees of One Hundred Fifty Thousand and No/100 (\$150,000.00) in case

number 22-09666-CZ and fees occurred in the instant matter of One Hundred Fifty Thousand

and No/100 (\$150,000.00).

The instant resolution will resolve the Michigan Employee Relations Commission case 2.

number 22-B-0358-CW currently before the Michigan Court of Appeals; and Case number

22-009666-CZ currently before the Michigan Court of Appeals.

The City of Detroit, through its health care consultant, will provide the Detroit Police Officers 3.

Association with de-identified healthcare data for the employees of the City of Detroit on a

monthly basis, for the course of seven (7) years.

The Court will retain jurisdiction to enforce the terms of the SA. 4.

Subject only to the terms of the SA, all claims in the case are dismissed. 5.

The SA will resolve the last pending claim and closes the case. 6.
