We have reviewed the above-captioned lawsuit, the facts and particulars of which are set forth in a confidential memorandum that is being separately hand-delivered to each member of Your Honorable Body. From this review, it is our considered opinion that a settlement in the amount of **NINETEEN THOUSAND THREE HUNDRED DOLLARS and <sup>NO</sup>/Cents (\$19,300.00)** is in the best interest of the City of Detroit.

We therefore request authorization to settle this matter in the amount of **NINETEEN THOUSAND THREE HUNDRED DOLLARS and <sup>NO</sup>/Cents (\$19,300.00)** and that Your Honorable Body direct the Finance Director to issue three drafts. The first draft in that amount of **SIX THOUSAND NINE HUNDRED DOLLARS and <sup>NO</sup>/Cents (\$6,900.00)** payable to **MUHAMMAD RAMZAH and HIS attorneys, WIGOD & FALZON, P.C.** The second draft in the amount of **SIX THOUSAND NINE HUNDRED DOLLARS and <sup>NO</sup>/Cents (\$6,900.00)** payable to **ISHMAEL MUHAMMAD and HIS attorneys, WIGOD & FALZON, P.C.** The third draft in the amount of **FIVE THOUSAND FIVE HUNDRED DOLLARS** payable to **CITY PHARMACY, LLC and ITS attorneys, SEVA LAW FIRM**, to be delivered upon receipt of properly executed Releases and Stipulation and Order of Dismissal entered in Lawsuit No.23-015239-NF, approved by the Law Department.
